LOCKER RENTAL AGREEMENT

IT IS AGREED UPON THAT ALL TOBACCO CONSUMED ON THE PREMISES SHALL BE PURCHASED FROM CAREFREE CIGAR CLUB, LLC (DBA STICKS GOLF & CIGAR LOUNGE), UNLESS BRAND IS NOT CARRIED.

Members agree to adhere to the following **policies and procedures**:

1. Lockers will only be rented on an annual basis to customers 21 years of age or older.
2. Lockers cannot be shared.
3. Security Deposit (\$100) for locker rental is due upon signing of Agreement.
4. The term of membership is one year and will automatically renew annually unless notice of cancellation is received 30 days prior to cancellation.
5. Rental fees will be charged monthly using member's credit card. Member agrees to provide credit card information and approval of reoccurring monthly charges. Standard Members will receive \$90 credit each month for purchase of cigars or other tobacco products only. Deluxe members will receive \$180 credit each month and a 10% discount on all purchases. Credit must be used in same month and any unused credits will expire at end of month.
6. One key will be issued per locker. Key must be returned at end of rental period. A fee of \$20 will be charged for lost keys.
7. Member understands that we continually monitor the temperature and humidity in our walk-in humidor for optimum storage conditions. However, we cannot be responsible for any products stored in personal lockers.



8. Members are responsible for the contents of their locker and agree not to store any illegal products/items in locker. Management reserves the right to open any humidor locker for inspection and maintenance and cancel the rental agreement for any violations of this agreement.
9. Members are responsible for any damage to locker.
10. Locker rental includes a personalized name plate on door of locker. Any changes to name plate will require a \$40 fee.
11. Member will remove any items from locker at end of rental agreement. Items not removed will be disposed after 30 days.
12. All locker rentals are final and non-refundable.
13. Locker members will receive priority status for special event invitations.
14. Terms and conditions of rental agreement, including fees, may change from time to time.

The undersigned agrees to follow the policies and procedures outlined herein. It is understood that Locker Rental is subject to approval, payment of \$100 deposit, and providing an executed credit card authorization form.
